Bud Wallik made a motion the police men drive thru the Cemetery to report once a week to Jack Scott Emmet suggested Make Up Hoff would help towards setting out Arboretas Jack Scott suggested we look into the Alley and offered to investigate Motion by Emmet to charge \$5⁰⁰ on or half a lot, seconded by Mort. Motion by Emmet to raise money by charging \$35⁰⁰ a sum. rec and \$40⁰⁰ in winter keeping out \$5. for each grave to be applied toward expenses
